

# Summary of Days 1 to 6 of the Grand Jury Process - The Court of Public Opinion Probably the Most Important Legal Process Ever on Earth

**Bill Gates, Anthony Fauci, Christian Drosten, Tedros Adhanom Ghebreyesus (WHO), Black Rock and Pfizer are about to be indicted for crimes against humanity. ## **Introduction to the Grand Jury Process**

The last two years of covid-19 have been different than other years. The world's governments have responded in a way we have not seen before. Our communities have been shut down for periods of time and there has been pressure to get tested and vaccinated. In many ways it has been a confusing time with conflicting information. It can be difficult to know what and who to trust. So before you are introduced further to the Grand Jury process, here is the background and for it, including who is leading it.

## **Background on the Grand Jury Process.**

In June 2020, four attorneys formed **the Berlin Corona Investigation Committee**. The lead lawyer in this group, as well as in the Grand Jury process, is **Dr. Reiner Fuellmich**, who in his time, among others, convicted **Volkswagen** of cheating on emissions from their diesel cars (**Dieselgate**), as well as Deutsche Bank. The Corona Inquiry Commission has conducted over 100 hearings of experts from around the world, totalling around 500 hours. Based on this, they have found that it is now time for a Grand Jury trial (inspired by American legal tradition), where evidence is presented to decide whether to indict for Crimes against Humanity.

## **The purpose of the Grand Jury process is:**

1. to present evidence to the people of the world at a People's Court called: The Peoples Court of Public Opinion. The goal is to give the public the full picture of what is going on. The process is facilitated by a group of highly regarded and successful lawyers and one judge. Expert witnesses in various fields will testify in the case.
2. Assess and decide whether to indict Christian Drosten, Anthony Fauci, Tedros Adhanom Ghebreyesus (WHO), Bill Gates, Black Rock and Pfizer for crimes against humanity

## **Summary of day 1 on 5 February 2022 - Opening remarks**

The background of the Grand Jury process, the legal basis (Natural Law) including the legal practice in the United States was reviewed by two American lawyers including a professor. Dr. Reiner Fuellmich gave an overview of various facts pointing to a planned crime against humanity with lots of lies. The "vaccines" are anything but safe! Alternative and safe treatments against covid-19, used with great success, were presented. And it was argued that even if a big lie was repeated thousands of times, it is still a lie.

## **Summary of Day 2, 12 February 2022 - The general historical and geopolitical background to all this**

The historical background was reviewed with the real centre of power located in the City of London and Wall Street in the USA. A financial mafia consisting of a small group of families including the Bill and Melinda Gates Foundation, the World Economic Forum and their Young Global Leaders have terrorized the world's population to gain total control. The Deep State is led by a small group of people, including Kissinger. A system similar to China's Social Credit System is planned to be spread to the entire world. The financial market has taken control of the WHO and the UN without any democratic legitimacy.

The Covid-19 crisis was created using a PCR test protocol proposed by Christian Drosten. The PCR test enabled the WHO to declare a pandemic and communicate a test pandemic, which eventually led to the injection of large parts of the world's population with the so-called "vaccines" - the imposition of lockdown, vaccine passports, etc.

## **Summary of Day 3 on 13 February 2022 - PCR testing (and alternative effective and safe treatments)**


Several doctors explained how the PCR test was introduced as a diagnostic tool, what it is not suitable for. Christian Drosten knew that the PCR test gives many false positives. Many people died as a result of treatment with Remdesivir, following the recommendation of Anthony Fauci. Remdesivir causes massive rates of liver failure, kidney failure and heart attacks.

In the UK (ed., and in DK) there was no excess mortality before introduction of the "vaccine", but there was after introduction. People without symptoms are not able to infect others. Hydroxychloroquine, Ivermectin, vitamins D and other known treatments have been found safe and effective since early 2020, making vaccination unnecessary!

## Summary of Day 4, 19 February 2022 - Injections and psychological warfare

During the testing of Pfizer's so-called "vaccines", several side effects were found so serious that it should have stopped the trials immediately. Instead, the alarming results were hidden. The toxic shots were sent out to the public, despite the knowledge of major adverse effects on some vaccine batches (ed., see graph with Data is from the US VAERS database. Similar huge differences are documented in Sweden and Denmark).

**Note (ed.):** Number of adverse reactions registered per batch for Pfizer. As you can see, there are 2 to 3,600 times, or 100% to 360,000% as many adverse reactions recorded from some batch numbers as from other batch numbers.

The Grand Jury will seek to prove in court that it was deliberate that the "vaccines"/injections harmed so differently. There was talk of the great mental damage the two years of isolation, etc. caused.

## Summary of Day 5, 20 February 2022 - Economic and Financial Destruction

Corona is a distraction, so what are we not allowed to see? Patrick M. Wood with [www.Technocracy.news](http://www.Technocracy.news) explained that capitalism is under attack by the Davos Group, World Economic Forum, UN, WHO, world elites, etc. The aim is to replace capitalism with a technocracy. Technocracy is an economic system similar to what China practices dictatorially with massive surveillance and control of the population.

The process began on the initiative of David Rockefeller (in 1973), later the UN (in 1974), Gro H. Brundtland (in 1987), Agenda 21 of the UN in Rio (in 1992) and Agenda 2030 of the UN (in 2015). The aim is to control society completely, as described for example in Orson Welles' novel 1984. The world elite wants to own the primary resources of the planet.

Developments in Canada clearly show that it is not about health, but about power and control. The globalists want centralisation of power in a world government integrated via the WHO and the UN, combined with a digital control network of digital programmable currency, digital surveillance, digital ID, vaccine passports, etc. In March 2022, the Danish Parliament voted that all Danish phone calls and emails should be monitored, - as an example.

## Summary of Day 6 on 26 February 2022 - Eugenics + closing arguments and the way forward
