#### Introduction

This report shows the Adverse Reactions (ADR's), as reported for your country in the EudraVigilance database from the European Medical Agency (EMA). The data has been obtained by special FOI request by the authors and contains data for 93 countries, EU, non-EU and the World.

#### The Data

The data is the registration of all reports made by healthcare professionals or individuals, whenever a side effect occurs. The data in this report is specifically related to the Pfizer/BioNTech Comirnaty Covid-19 vaccine. Generally the data is very underreported due the way these reports are collected. Health professionals and individuals have to report ADRs by own initiative, and this does not always happen. In the US the underreporting factor is estimated between a factor 10 and a factor 100 and this is probably also the case for this data. The underreporting will probably also vary greatly between countries. ADR's and deaths are registred pr. batch. If an individual has received more than one vaccination the ADR or death is counted for each vaccine the individual has received.

#### **EU countries**

For alle EU countries (excluding the UK), all registered ADRs are reported, both non serious, serious and deaths. One point to keep in mind is that your own countries medical authorities might not have processed all reports and therefor the data you see might not represent the whole picture. This can be investigated by contacting your country's health services and asking how many reports have been processed and how many are waiting.

#### **Non-EU countries**

For non-EU countries only serious ADR's and deaths are reported, so the data you see will be very limited.

#### Why are we publishing this?

After working with both VAERS data (USA + World), EMA data (EU + World) and the Danish data, we believe that the data clearly shows that the separate vaccine batches results in different numbers of ADR's. From the Danish data, we speculate, that this difference might be up to a factor 6000. Essentially this makes it impossible for anyone to know the risk associated with vaccination. It is also impossible for healthcare professionals to inform patients about the correct risk associated with vaccination, since it may differ wildly. Lastly if a parent takes a child or minor to be vaccinated, this person can't know the risk either.

This makes informed consent to vaccination impossible in all cases and if this is the case it is a serious breach of the first point of the Nuremberg Code, Article 5 of the Oviedo convention, Article 3.2.a in the Charter of fundamental Rights of the EU, and many others. Generally local health law requires informed consent and therefore this finding makes all Covid-19 vaccinations with this vaccine illegal.

We are not quite there yet, and what you can do.

While we firmly believe that the data does indeed show large differences between batches, that cannot be explained by batch sizes or other factors, the data will likely not be accepted by a court, because the batch sizes are not generally known. The only parties who are in possession are the vaccine companies and your health authorities. If you want to create this proof for your country, you need to:

- Download the data, behind this report.
- Request a list of how many doses of each vaccine batch your health authorities have purchased, through a FOI request to your health authorities.
- Using the number of ADR's pr. batch, divide by the number of used doses pr. batch and multiply by 100.000 yielding the number of ADR's pr. 100k doses.
- Using the number of deaths pr. batch, divide by the number of used doses pr. batch and multiply by 100.000 yielding the mortality for each batch.

If there are significant differences between batches, you have proof for your country, that the vaccinations were illegal. This proof can be utilized in compensation cases for damages, or cases against persons or institutions who have pressured or forced their citizens the be vaccinated.




## Adverse reactions pr. vaccinebatch sorted by ADR's

The figure shows the number of adverse reactions pr. vaccinebatch and is sorted in a decending order. Take note of the sharply decaying pattern, seen in most repports, which indicates that a minority of vaccinebatches are responsible for the majority of ADR's. I other words, the vaccinebatches are not equal with regards to adverse reactions.



## Adverse reactions pr. vaccinebatch sorted alphanumerically by Batchnumber

The figure shows the number of adverse reactions pr. vaccinebatch and is sorted alphanumerically by Batchnumber. Batch series are given separate colors (EM, EN, etc). Note that while most batches shows a very low number ofr ADR's, a few batches from each batch series shows an extremely high number of ADR's. The pattern is generally non-random, and if we assume that the alphanumeric sequence of batchnumbers represents some kind of order in production, this pattern proves, that the extreme fluctuations are not a result of production variability and lack of qualitycontrol. The pattern must therefore be caused by something else.



### Deaths pr. vaccinebatch sorted by number of Deaths

The figure shows the number of deaths pr. vaccinebatch and is sorted in a decending order. Again take note of the sharply decaying pattern, seen in most repports, which indicates that a small minority of vaccinebatches are responsible for the majority of deaths. I other words, the vaccinebatches are not equal with regards to deaths either.
