

COVID-19 VACCINES ARE UNSAFE AND THEREFORE ILLEGAL

- ACCORDING TO THE DANISH HEALTH ACT §15, STK. 1 AND 3 AND THE OVIEDO CONVENTION.

- **FACTS AND DRY FIGURES**
- In May 2020, statistics showed that those who died with covid-19 were on average older than life expectancy + had other serious illnesses
- In 2020 and 2021, there was great pressure on Danes to be vaccinated against covid-19
- In 2020, there was no excess mortality in Denmark. There has been since May 2021



Covid-19 vaccines are unsafe. Pfizer's own data as of 28 February 2021 showed **1291 different adverse reactions**, - including adverse reaction symptoms equivalent to **monkeypox + 1223 deaths!**

So keep yourself and those you care about far away from covid-19 vaccines - and spread the word - now!

THE VACCINES ARE LIKE PLAYING RUSSIAN ROULETTE

There is a big difference between whether a covid-19 vaccine is harmful or not. Some vaccine batches cause only a few side effects, while others cause thousands of side effects. Statistician Max Schmeling can document this.

So, accepting the covid-19 vaccines is like playing Russian roulette.

In June 2022, Max Schmeling informed Parliament that **the most harmful vaccine batch caused 118,000 times more harm per dose than the least harmful one (link 1).**

The big difference means the vaccines are unsafe. This makes them illegal according to the Danish Health Act §15, paragraphs 1 and 3 and the Oviedo Convention. It is impossible to give informed consent.

A similar serious problem has been shown for Pfizer's vaccine in over 30 countries, in the EU and the World by Max in collaboration with dissensMEDIA (**Link 2**)

The question is not, how many shots you've had, but what batch you've had injected into your body!

THE MEDICINES AGENCY, THE STATE SERUM INSTITUTE (SSI) AND THE MINISTER OF HEALTH HIDE THE PROBLEM

Although the Danish Parliament, the Prime Minister, the Danish Health Authority, the Danish Medicines Agency and SSI etc. are aware of the uncertainty of the vaccines, **the authorities conceal the serious problem and continue to recommend the illegal vaccines - [e.g. at the press conference on 22 June 2022!](#)**





Adverse reaction rate per batch from the Pfizer alias Comirnaty vaccine - divided into three types



- We see here the division of the Pfizer vaccine batches into 3 groups/types according to how many adverse reactions have been recorded from them
- Vaccine type 2 and type 3 give on average 28.7 times and 1034 times as many side effects as type 1
- On a single batch, however, the difference is much higher, at 33,480 times, a difference of 3.3 million
- For example, more than 180 out of 1000 doses caused adverse reactions for batch EJ6796. It corresponds to over 18%.
- It should be seen in the light of the fact that experience shows that only 1 to 10% of adverse reactions are detected!

Below is the distribution of Adverse reaction and doses from Pfizer - in relation to the three types



- **Translation:** Dødsfald=Deaths, Alvorlige bivirkninger=Serious Adverse Reactions (AR), Bivirkninger=AR, Doser=Doses
- The implications of this are that even if you personally have not experienced death, serious side effects or adverse reactions to the vaccine, many have. You have probably received a dose from the 32+64=96% from type 1 and type 2, - that has not harmed as much as type 3

Below is the distribution of the three types of Pfizer vaccine – injected into different age groups
