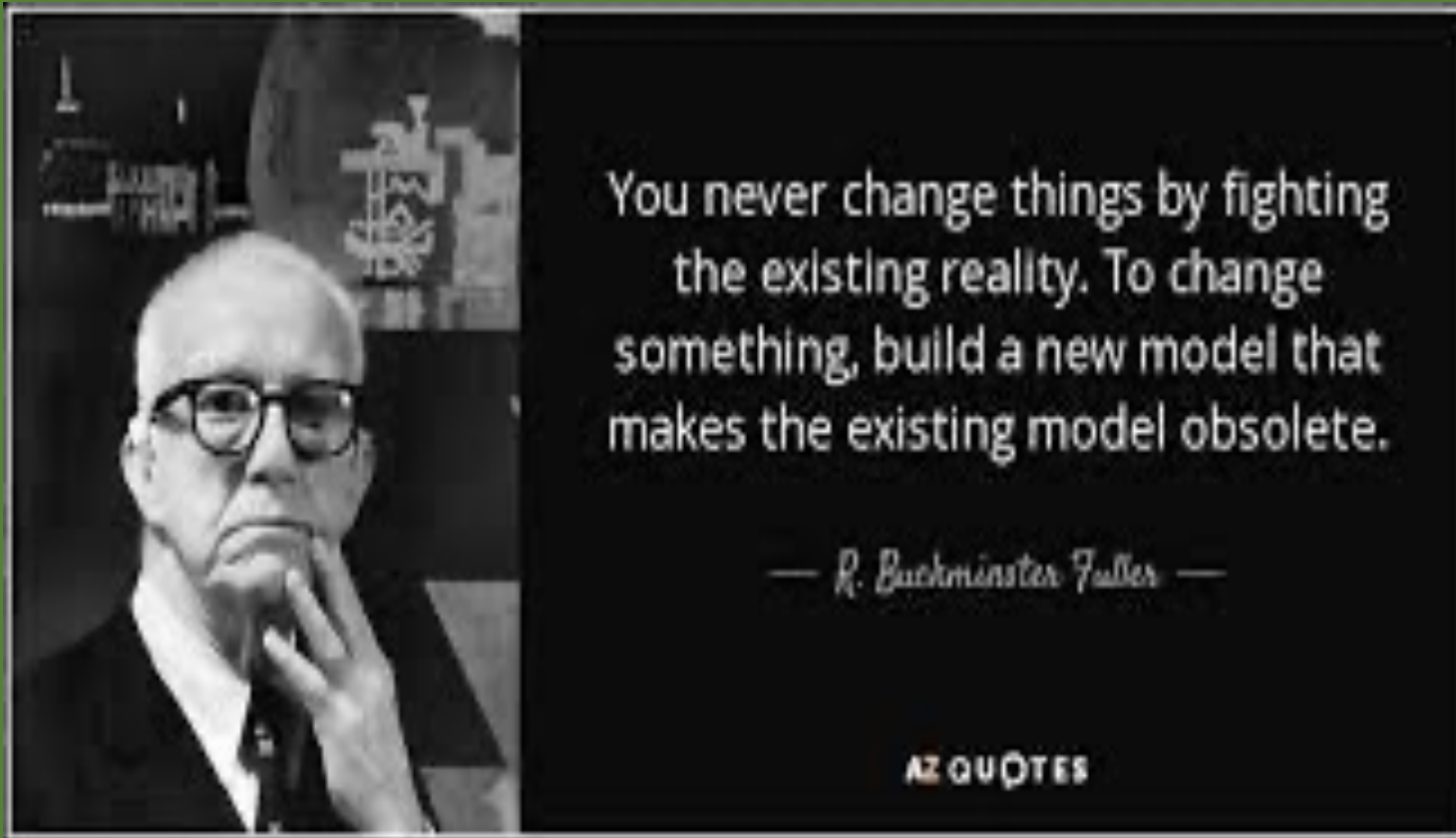

Medical errors and adverse events: leading cause of death and disease burden

Professor Dolores Cahill outlines opportunities to reduce medical error and adverse events in primary, ambulatory and hospital healthcare settings to benefit patients and save costs

Medical error is the third commonest cause of death, accounting annually for one in ten deaths (251,454 deaths) in the USA. This is behind causes of deaths from heart disease (611,105 deaths) and from cancer (548,881 deaths).¹ One in ten hospitalisations in OECD countries results, on average, in safety

patients relate to errors in diagnosis, surgery, prescriptions and the use of medicines.

The recent OECD reports 'The Economics of Patient Safety – Strengthening a value-based approach to reducing patient harm at national level' (2017)² and 'The Economics of Patient Safety in Primary and

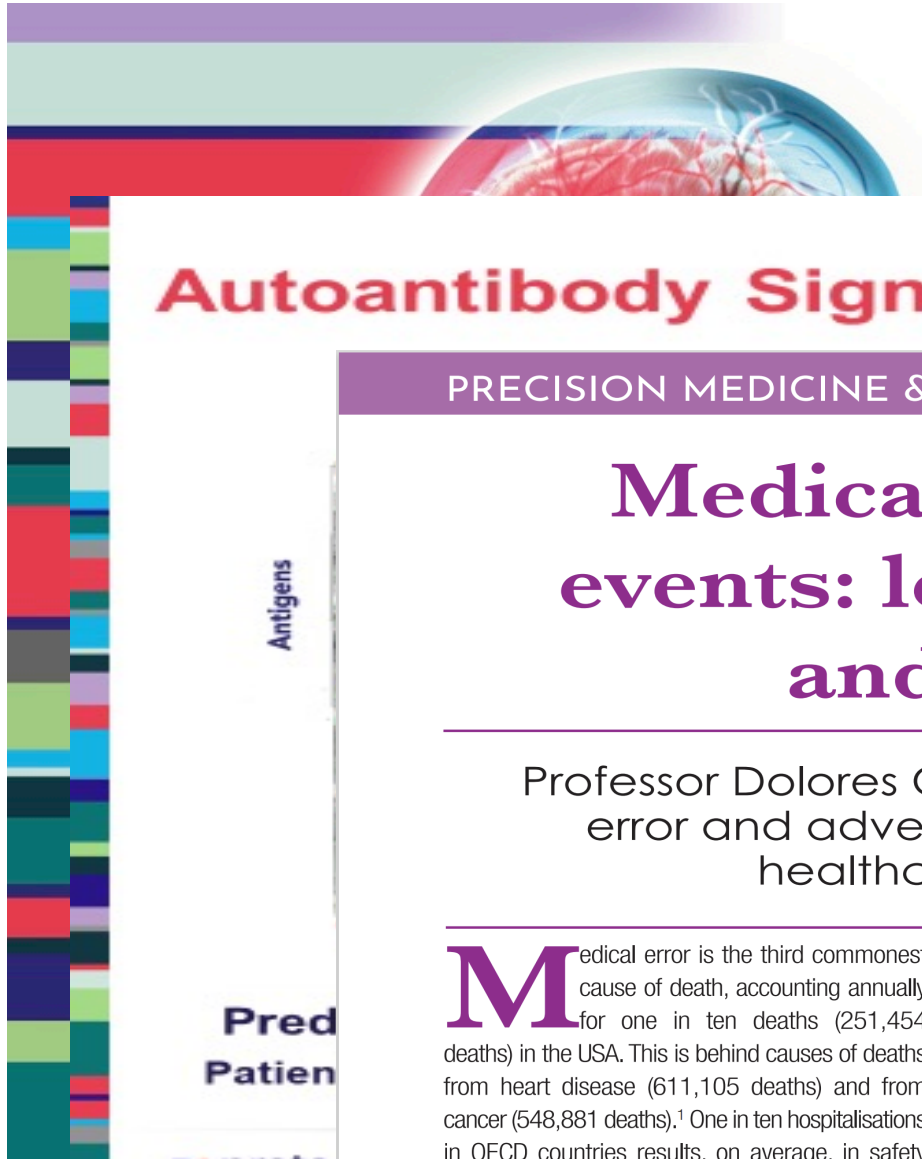

Dear Sir,

I refer to your letter dated 31st July last with enclosure.

Regarding the 1919 Constitution of Dáil Éireann it was repealed when the Constitution of the Irish Free State came into force on 6th December 1922. The 1922 Constitution, in turn, was repealed by Article 48 of the 1937 Constitution. The 1937 Constitution was approved by a plebiscite of the Irish people held on 1st July 1937.

Thus, the 1919 Constitution to which you refer does not have legal effect.

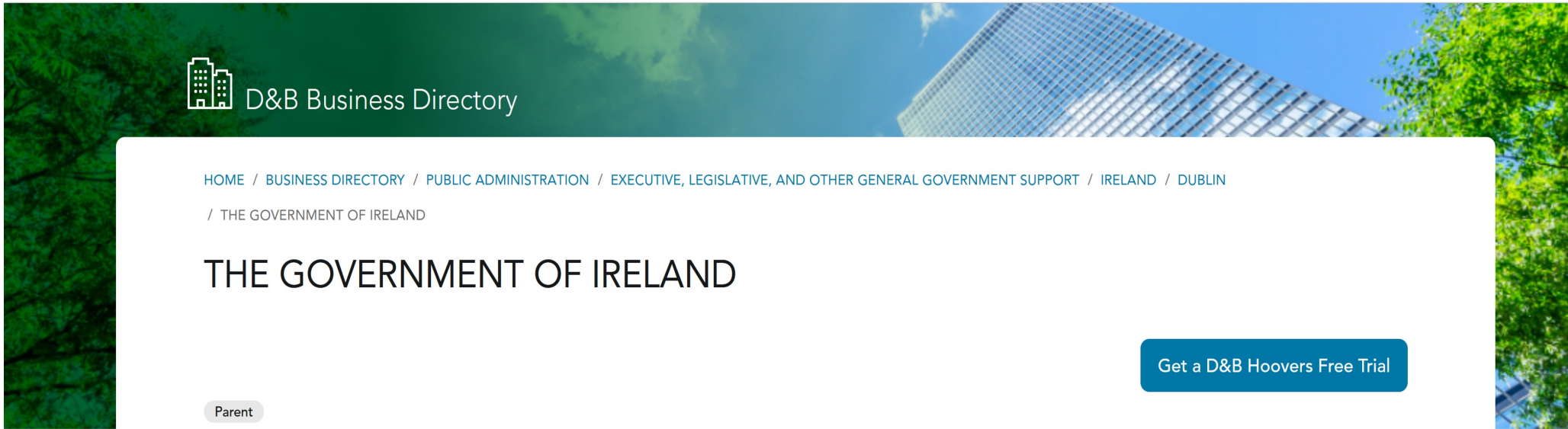
It is concerning that you hold yourself out as a person authorised to issue licences to judges. The judges of the State are appointed by the President and this function is performed "only on the advice of the Government". As was held in *Beades .v. Ireland* [2016] 2 I.R. 224 at paragraph 49 this decision is non-justiciable. Furthermore, kindly note that attempting to usurp the Government's position constitutes an offence.

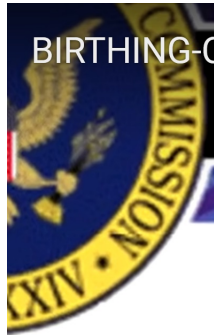

Dear Sir,

I refer to your letter dated 31st July last with enclosure.

Regarding the 1919 Constitution of Dáil Éireann it was repealed when the Constitution of the Irish Free State came into force on 6th December 1922. The 1922 Constitution, in turn, was repealed by Article 48 of the 1937 Constitution. The 1937 Constitution was approved by a plebiscite of the Irish people held on 1st July 1937.

Thus, the 1919 Constitution to which you refer does not have legal effect.

It is concerning that you hold yourself out as a person authorised to issue licences to judges. The judges of the State are appointed by the President and this function is performed "only on the advice of the Government". As was held in *Beades .v. Ireland* [2016] 2 I.R. 224 at paragraph 49 this decision is non-justiciable. Furthermore, kindly note that attempting to usurp the Government's position constitutes an offence.

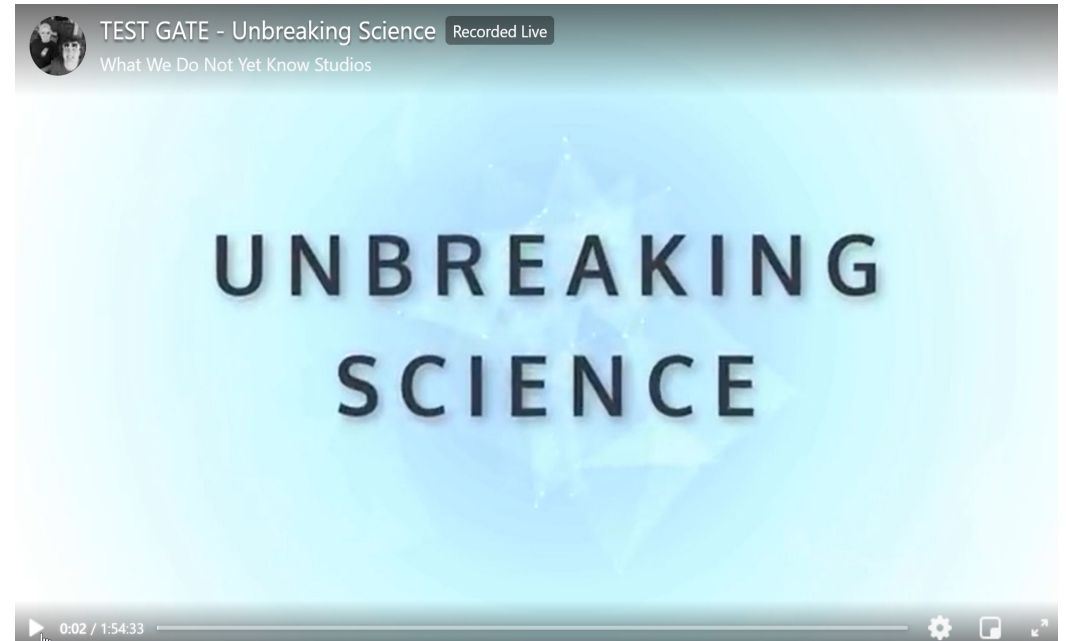

Spotlight: Hammond Report Exonerates IPAK Collaborator Dr. Paul Thomas, Finds "Rogue Medical Board" Tried to Coerce Unlawful Medical Practice

Independent journalist Jeremy Hammond has authored a definitive and thorough report that reveals that the Oregon Medical Board is guilty of wrong-doing because they tried to coerce Dr. Thomas into changing his lawful pediatric practice into an unlawful medical practice under Oregon's state law. The 210-page report reads, in part *"The real story here isn't one of a rogue doctor dismissing science and recklessly endangering his pediatric patients by bullying their parents into accepting 'alternative' care. The real story is one of a rogue medical board dismissing science and recklessly endangering public health by encouraging pediatricians to bully their parents into strict compliance with the CDC's schedule and selecting Paul Thomas, MD, to set an example to other physicians of what their punishment will be if they instead choose to respect parents' right to informed consent."*

Under Oregon state law, physicians, including pediatricians, must provide for fully informed consent and respect vaccine refusal. The board had tried to sanction Dr. Thomas for allowing patients to use antibody titre-testing as evidence of immunity. It found that the board's actions were *"ludicrous given the fact that Oregon law only requires one dose of mumps vaccine, and it specifically allows for the use of antibody testing as evidence of immunity in lieu of evidence of vaccination."*

The report also completely rebuts all eight of the allegations of medical misconduct alleged by the Oregon Medical Board. Under current Oregon law, The Board answers to the Governor of the State of Oregon.
